Batteries, Automotive ^T : (Lead/acid vehicle batteries)	Cover Terminals & Label as Universal Waste with Accum. Start Date	Bring these batteries to the UConn Motor Pool (860) 486-3029 for proper disposal.

Asbestos ^T containing material or suspected asbestos containing material	DO NOT remove asbestos. Must be removed by a licensed abatement contractor.	Contact Facilities Work Order Control at (860) 486-3113. UConn Facilities and EH&S will contract an asbestos abatement company for removal.
Freon/Refrigerant Gas-containing Equipment ^T (refrigerators, air conditioners)	Have Facilities remove all CFCs from the Equipment & Label	Contact Facilities Work Order Control (860) 486-3113. The HVAC Shop will recycle or contract local recycling company for disposal
Petroleum Products ^T (used oil, fuel filters, oily/fuel soaked rags)	Contact EH&S for proper labeling.	Contact Denis Shannon (860) 486-3115 or the EH&S Office at (860) 486-3613 or our web site http://www.ehs.uconn.edu/serv.html

Oil Containing Equipment	Have Facilities remove all oil from the Equipment & Label	Dispose of oil as Petroleum Products
